## ***GENERAL TERMS AND AGREEMENT***

- I agree to represent Decent Pieces in a truthful, professional, and sincere manner.
- I understand that I must be 18 years or older to be a Decent Pieces Consultant.
- I understand that I cannot have consultants under me.
- I understand my contract is between Decent Pieces and myself and that the terms of this agreement are governed by the laws according to the state of Maryland.
- I understand I am not a shareholder, partner and have no ownership of Decent Pieces, LLC I am not in joint ventures with or franchisee, partner, agent or employee of Decent Pieces LLC. I have no power to incur any debt obligation or liability on behalf of Decent Pieces, LLC.
- I understand that I can not be an Independent Consultant with any other jewelry company when a consultant with Decent Pieces.
- I understand that I must submit an "Inquiry" to Decent Pieces, LLC before I sign up to do any events other than a home shows to prevent conflict of interest.
- I will obtain Decent Pieces, LLC written permission prior to using the Decent Pieces LLC name or likeness in any advertising other than material produced by Decent Pieces, LLC.
- I understand that any refunds given are solely at the digression of Decent Pieces, LLC.
- I understand that the starter kit is not refundable.
- I understand that all jewelry is inspected twice before shipped and refunds are subject to strict 2 day turnaround if merchandise is damaged upon arrival.
- I understand that this is a 1 year contract and I am responsible for purchasing \$200 in merchandise for 12 consecutive months to avoid violation of this contract.
- I agree to make a minimum \$200 monthly purchase from the Decent Pieces, LLC consulting website to stay an "active consultant."
- I understand that Decent Pieces only accepts credit cards, certified checks, and money orders for payment of merchandise. All Certified Check/MO must be made payable to Decent Pieces, LLC for the full amount due.
